**TRADITIONAL STAY ACTION IN THE MATTERS BETWEEN MR. ASUQUO ABRAHAM (PLAINTIFF) AND MRS. CHRISTIANA MONDAY ABRAHAM (DEFENDANT) BOTH FROM NKAP VILLAGE, NTO EDINO CLAN IN OBOT AKARA LOCAL GOVERNMENT AREA OF AKWA IBOM STATE - NIGERIA.**

I am directed to write to you on the above subject matter and to inform you and your Traditional Ruler's Clan Council Members that this Institution of Justice has received a Protest from one Mrs. Christiana Monday Abraham (A Widow) of the above Village Clan and Local Government Area and State on May 11, 2010 of her displeasure and not Comfortable for you and your Council to preside over the matter brought to you by one Asuquo Abraham because of the below reasons:-

1. That you His Highness Chief Asuquo Akpan Enang who is the Clan Head and Chairman of Nto Edino Clan Traditional Rulers Council made a statement on the 10<sup>th</sup> May, 2010 in your Palace that you and your Members are out to share the Landed Property of Late Abraham Nsisop without taking into Consideration the Cultural Rights, Norms and Taboos of Nkap Village and Annang Land that must be first' complied with before you discussed the sharing of the landed property which effects is always the dead in the family.
2. That since you are anxiously out to deliver Judgment without hearing, findings of the Case her Justice, Rights will be Denied which would amount to permanent Conflict in the family.
3. That the problems between her and Asuquo Abraham is a Social Conflicts and can be only resolved through accountable and Transparent Institution and not an Institution which is corrupt.

4. That Justice will not be done in the matter before you.

The petition was investigated and analyzed and found all to be credulous. Therefore since International Human Rights & Anti-Corruption Society is Defending and Protecting Justice, fight against Corruption, Moral Decadence, Injustices, Violation of Human Rights and Cultural Rights in all ramifications and also to ensure that all Citizens, Groups or Organizations obtain justice whenever there is impinged or suppressed.

Therefore, since there is doubt and fear in the Matter before you and your Council Members on the part of the Defendant, Mrs. Christiana Monday Abraham has both the Statutory, Cultural and Constitutional Rights to seek for Justices and therefore the International Human Rights and Anti-Corruption Society from the date of the receipt of this Letter had directed you and your Council Members to Stay Action on the Matter as the Matter is now being handled by the Directorate of Social Conflicts and Peace Resolution of this unique Institution and a date shall be communicated to both parties.
